

Terms & Conditions: 2024 Auckland Branch AGM

Definitions:

- Plastics New Zealand Incorporated (PNZ or Plastics NZ).
- Member: individual, or group of individuals, from a paid-up company member of PNZ.
- Non-Member: individual, or group of individuals, from an organisation that is not a member of PN7
- Registrant: is the person registering for the event.
- Registered Attendee: is the person attending the event.
- Ticket: under these Event Terms and Conditions includes a ticket, pass, credential, or other authorisation sold or granted by Plastics New Zealand allowing entry to the specified Event
- Pool: Limited Number of Attendee places available for the event
- Force Majeure: any act, event of circumstance beyond the reasonable control of PNZ which has a substantial impact on PNZ, the event venue(s), or the geographical area in which PNZ and/or the hotel operates. The act, event or circumstance could include, without limitation, casualties, war, rebellion, revolution, blockades, riots, insurrection, strikes, lockouts, labour or industrial problems, civil unrest, embargoes, domestic or international disturbance, acts of terrorism, an outbreak of disease, virus, pandemics or epidemics, world and/or regional health threats, loss or substantial reduction in major airline services, governmental actions or delays, fire, cyclones, earthquakes, storms, floods, other natural catastrophes or severe weather conditions or acts of God, travel or health advisories, orders or recommendations issued by any relevant government authorities or international bodies or agencies, or damage or destruction of the event venue.

Bookings:

- 1. Attendee placements are limited. Submission of a registration form and/or payment details to Plastics NZ does not constitute automatic confirmation of Booking.
- Bookings are confirmed on receipt of payment. A confirmation email from PNZ and issuing of receipt will be provided.
- 3. All Attendees must be 18+ years of age to attend the event.
- 4. A Registrant may book Attendee placements on other's behalf.
- 5. Registered Attendee details (Name, email and contact phone number) must be provided prior to the issuing of tickets for the event.
- 6. A Ticket to access the venue will be issued via Plastics NZ to Registered Attendees approximately one month prior to the event occurring or, if after this point of time, when the Registered Attendee details are provided.

Payment:

- 1. All Attendee placements must be paid for at the time of booking.
- 2. Plastics NZ accepts payment via selected credit cards only, direct payment or 7-day invoice (Members only) which will be emailed upon registration.
- 3. Any Attendee placement not paid in full within 7 days of booking, will be released and the placement will go back into the available pool.
- 4. The cost per registration is in New Zealand dollars (\$60 NZD) and includes GST (15% GST).

Attendee Cancellation & Non-Attendance:

Once Bookings are confirmed by way of payment, the following cancellation conditions apply:

- Cancellations must be made in writing and confirmed with a confirmation email from PNZ to be valid.
- Substitutions under the exact same booking conditions may be made in the event that the original attendee cannot attend. Notification of a substitute must be made to PNZ at the first possible opportunity.
- 3. Cancellation of attendance prior to 1st July 2024:



- a. 100% of payment will be refunded, less a \$10 administration fee (per attendee). Attendee placement will be released back into the pool.
- 4. Cancellation of attendance after 2nd July 2024:
 - a. No refund of payment. Attendee placement will be released back into the pool.
- 5. No refunds will be provided in the event of registrant non-attendance at the Event.

Event Cancellation or Postponement:

- 1. Where the Event is cancelled due to Force Majeure, or government regulation restricting event numbers or travel, PNZ will refund the recoverable portion the event. Cost recovery is not guaranteed as it is dependent on individual supplier contracts and responses to said event/regulation.
- 2. If the event is cancelled by PNZ for any other reason, fees will be refunded in full.
- 3. PNZ will not be held responsible for any loss of funds incurred due to cancellation of travel. We recommend you check the cancellation and refund policies of your travel and transport providers and book fully refundable or changeable options where you can.
